"The Single Form PDF 2014"

The course will provide participants with a general overview of the Single Form and its structure, explaining how to use the main functionalities, to attach files and to upload the Single Form on APPEL.

"The Audit process 2014"

This course intends to clarify to participants issues related to the Audit process. The training affords both the general audit process, through the description of the various steps of both field and HQ audit, and specific questions that may arise during the audit itself.

"A very short introduction to the 2014 FPA"

Become familiar with DG ECHO, its working modalities and with the main elements of the 2014 FPA. During the course, you will be able to start working on a DG ECHO funded Action, from the preparatory phase

through its implementation and closure.

"Final Report 2014"
